Federal & State Grant Funding

- Each year, BCSD receives an annual allocation of grant funds to be used to support programing in order to provide all students with equitable access to education.
- Annual applications are filed with the NYS Education Department and must be submitted and approved based on criteria set by New York State.
- Accountability measures are incorporated into the grant application process in order to monitor the receipt and management of funds.

Every Student Succeeds Act (ESSA)



The Every Student Succeeds Act (ESSA) is a U.S. law that E outlines how states can use federal money to support public schools.

ESAA provides federal funding to **improve elementary and secondary education** in the nation's schools.

In January 2018, the federal government approved NYS's plan to spend the approximately \$1.6 billion NYS receives annually in funding through ESSA.

ESSA requires that states and Local Educational Agencies take a variety of actions to ensure that all children, regardless of race, socioeconomic status, gender, disability status, primary language, or ZIP code, receive the education they need to be prepared for success in postsecondary education, careers, and citizenship.

Coronavirus Aid, Relief, and Economic Security (CARES) Act



- On March 27, 2020, Congress passed, and the President signed into law the CARES Act. The Emergency Relief funds are to be used to address the impact that the coronavirus (COVID-19) has had, and continues to have on elementary and secondary schools across the nation. The grant includes:
 - Governor's Emergency Education Relief (GEER) Funds
 - Elementary & Secondary School Emergency Relief (ESSER)

Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA)

On December 27, 2020, the President signed into law the **CRRSA Act** which authorizes funding for a second Education Stabilization Fund to prevent, prepare for, and respond to the coronavirus and its impact on education.

Funding Period: 3/13/2020-9/30/2023

- Hiring additional staff to address learning loss including summer programming
- Summer programming materials and transportation
- Technology software
- PPE supplies, cleaning & disinfecting supplies
- HVAC filters, HVAC and window repairs
- Training for custodial staff on disinfecting techniques
- Quarantine support staffing



American Rescue Plan (ARP) Act



On March 11, 2021, the President signed into law the American Rescue Plan (ARP) Funds in order to:

- Support the safe return to in-person instruction
- Address the impact of lost instructional time through the implementation of evidence-based interventions, including summer learning programs
- Maintain safe operations while meeting the academic, social, emotional needs and mental health needs of students resulting from the COVID-19 pandemic
- Address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care.



American Rescue Plan (ARP) Act

- School Nurse (1.0 FTE)
- RULER curriculum summer work
- Custodial overtime for cleaning and disinfecting
- Technology software and hardware
- PPE, cleaning, and HVAC supplies
