- Continues to provide summer 2022 opportunities for students to access support and interventions.
- Focuses on class size to keep student-to-staff ratio small and within the lower limits of Board policy guidelines.
- · Remains current and provides high-quality instruction and professional development.
- · Invests in innovation, design thinking, digital citizenship and interdisciplinary STEAM curriculum.

Dear Bedford Central School District Residents,

On April 6, the Board of Education unanimously adopted the proposed 2022-23 budget that will be presented to you, the voters, on May 17, 2022.

We are pleased to present a budget that continues to honor our commitment to "Inspiring and Challenging Our Students" while serving as a tool to foster and support equitable opportunities for all.

While the impact of time lost during the pandemic will drive our programming and instructional models for years, we believe the BCSD is in a solid position, that our students and staff have accomplished much and have demonstrated significant achievement. While still addressing the social, emotional and academic needs of students, this budget is both proactive and progressive and presents a blueprint for the Bedford Central School District that is one of forward visioning with the pandemic optimistically in our rearview mirror. It reflects our core values by taking a "students first" approach, ensuring that the student experience is at the center of everything we do.

The principles which guided the development of this budget are:

- Enhancing programs for students, exploring new and innovative programs and initiatives, expanding analysis of student achievement data, and continuing our investment in professional development
- Maintaining favorable class sizes and ensuring expenditures that have direct impact on student experience, voice and equitable opportunities
- Aligning the 2022-23 budget with prior years' actual expenditures, including pre-pandemic school years
- Limiting projected expenses and maximizing potential revenue to stay within the legislative property tax levy cap
- Complying with state and/or federally mandated programs with minimal additional costs
- Continuing to maximize operational efficiencies.

What's new in this budget:

- Additional staffing that includes a third assistant principal at FLHS
 which will make supervision comparable to neighboring districts, a
 K-12 Ed Tech Specialist/STEAM Teacher Coach, a K-5 Math Teacher
 Coach, a Bilingual Community Liaison, and additional teachers for
 Special Education, Art, PE, and Music
- A new K-5 math curriculum and a new eighth grade Earth Science Regents course for FLMS
- · New musical instruments and art supplies
- · An overhaul of athletic uniforms and athletic equipment
- Introduction of new athletic teams and additional coaching positions
- Funding for new extracurricular clubs at FLHS and FLMS

In summary, this budget continues our efforts to provide outstanding educational programs for students, as we continue on our path to BCSD's sustained fiscal health.

We remain committed to our BCSD mission: To cultivate curiosity and a passion for learning by providing challenging educational opportunities for all students so they may achieve their full potential as productive and contributing members of society.

BEDFORD HILLS ELEMENTARY SCHOOL

BHES celebrated many of our traditions again this year. The principal's dunking booth to reward summer reading was a big success. Third and fourth graders performed in the African Dancing and Drumming program. We celebrated Dr. Seuss week with special events including community readers, Seussland and plays performed by the fifth grade. Second graders worked with Visions and Voices to write plays that were performed by professional actors. Fifth grade will be celebrating with a trip to Boundless Adventures and Lake Compounce. We were excited to welcome parents back into the building for many of these special events!

BEDFORD VILLAGE ELEMENTARY SCHOOL

- A long-standing tradition at BVES is the Kindergarten/Fifth Grade Buddies. Fifth graders are matched to kindergarten students and serve as mentors, reading to their buddies and helping with projects. It provides leadership experience and builds a special bond between the grades.
- BVES is committed to social-emotional learning and building a climate of CARE. Through the implementation of RULER, students and staff are using tools like the Mood Meter, Community Circle and the Charter to identify emotions and build social-emotional skills. Schoolwide participation in The Great Kindness Challenge extended this learning. In addition to ongoing acts of kindness, students filled the hallways with kind messages about their peers and staff, and wrote letters of gratitude to bus drivers.

FOX LANE HIGH SCHOOL

- 14 students represented Fox Lane at the 2022 New York State Science Olympiad Tournament. Students earned two top-10 finishes, proving to be one of the top teams in New York. Our Science Research students have also had a successful year, receiving local, state and national recognition in various competitions.
- The ESOL and World Language departments collaborated to assess more than 40 candidates for the Seal of Biliteracy.
- Fox Lane musicians continue to inspire! Among other prestigious events, Jazz Band and Chamber Choir performed in Albany as part of the New York State School Music Association's Music in Our Schools Month celebration. Fox Lane also had two small orchestra ensembles perform at the Chamber Music Society of Lincoln Center's Third Annual Young Musicians Regional. Fox Lane was one of only four high schools in the region invited to perform at this prestigious event.

FOX LANE MIDDLE SCHOOL

- This year, Principal Harrison created a Principal Advisory Committee. About six students per grade level meet with Harrison monthly to discuss their experience at FLMS. Students share what is going well and areas that they feel may need attention or improvement.
- On Fridays, staff and students engage in schoolwide RULER lessons and discussions. Our focus for this year has been on understanding the Emotions Matter mindset, creating staff and student Charters and utilizing the Mood Meter Tool.

MOUNT KISCO ELEMENTARY SCHOOL

- Mount Kisco Elementary is Rooted in Love! We celebrated the tenth anniversary rededication ceremony for the MKES Community Garden and all that it represents for our community.
- In mid-January, MKES fully integrated dual language bilingual education into our kindergarten classes. By implementing the program to our newest generation of learners, the academic benefits are even greater, as it takes five to seven years to be proficient in a second language.

POUND RIDGE ELEMENTARY SCHOOL

- This year, we debuted PRES Student News, a video news show that is written and produced primarily by fifth graders. Students showcase school events and field trips and embed creative, original segments such as "Myth Busters," "Ask a Fifth Grader," and "Fresh Faces at PRES."
- While March was National Nutrition Month, PRES has been focusing on health and wellness all year long. From the Fun Run (our fall PTA fundraiser) to a robust calendar of nutrition education, challenges and programming in March to our first Wellness Fair, PRES is prioritizing healthy habits!

WEST PATENT ELEMENTARY SCHOOL

- WPES was redesignated as a State School of Character and is awaiting word from the national level. This year, as we continue our RULER implementation, we integrated our Character Core Virtues and focused on the emotional wellness of our entire WPES community. In addition, social-emotional learning is everywhere: in literature, in social studies and even in our chicken coop!
- WPES is proud of our Enrichment for All programming! Every student is participating in woodworking, environmental science and gardening in the fall and spring. This year, we have implemented a thriving outdoor program, including caring for our chickens, extensive composting and partnering with FLHS in our Bee Friends initiative.

In the event of a contingent budget, the District is required to maintain the 2021-22 tax levy. The expense budget would require a decrease of \$3,517,327. This would necessitate elimination of proposed certified and classified staff positions, professional development, curriculum enhancements, co-curricular and athletic program enhancements. Additional deductions would be required in general education teaching positions, supplies and materials, reduced services from BOCES, eliminate expenses related to educational technology leases and capital equipment, removal of non-contingent expenses such as instructional and operating equipment. The three component budget reductions would be:

Administrative Reduction: \$666,946 Program Reduction: \$2,374,018 Capital Reduction: \$476,363

The budget to budget increase would be .034%. This statement of assumptions is projecting a contingency budget for 2022-23 school year, should the proposed budget be defeated pursuant to section 2023 of the Education Law.





What happens if the budget doesn't pass?

Should the proposed budget be defeated, \$3,517,326 in non-contingent expenditures would need to be removed in a contingent budget. These may include equipment purchases and repairs, unreimbursed community use of facilities, extracurricular clubs, athletics, electives and advanced placement courses, certain student supplies and staffing reductions which may lead to increased class sizes.

Voter Registration

To vote in school elections, you must be a registered voter for either school elections or general elections. To be eligible to register, you must be a U.S. citizen, 18 years of age by the election date and a resident of the district for at least 30 days before the election. The last day for registration with the district is May 12, 2022.

Absentee Ballots

An application must be submitted before an absentee ballot can be provided to a voter. Applications for absentee ballots must be completed and received by the District Clerk at least seven days before the election if the ballot is to be mailed to the voter, or the day before the election if the ballot is to be delivered personally to the voter. Absentee ballot applications are available from Sandra Speyer, District Clerk, at the Administration Building on the Fox Lane Campus during regular business hours (8 am - 4 pm) or by downloading the application: bcsdny.org/Page/2566
